- 1) The word "IFCAL" wherever mentioned in this tender document shall mean the company Idcol Ferro Chrome & Alloys Limited having its Registered Office at Ferrochrome Project-755 020, Jajpur Road, Dist: Jajpur (Odisha).
- 2) The "legal status" of the tenderer i.e. proprietory concern, partnership farm, private or public limited company or any other as per the case may be, shall be specified in the GENERAL BID format with documentary proof attached.
- 3) The person signing the tender document shall either be the Managing Director or the Proprietor of the company or the Active Partner of the farm, otherwise the Letter of Authority to sign the tender on behalf of the company / farm / individual shall be enclosed. Full signature of such authorized person should be put on each page of the tender documents with rubber seal.
- 4) The tenders (also called bids) not submitted in prescribed formats or in the prescribed manner, as stipulated in this document, shall be rejected at the risk & responsibility of the tenderer.
- 5) All the information, as called for in the tender document, should be submitted truly, clearly, legibly, transparently, unambiguously and without the use of abbreviations. It shall be submitted in English.

1) Eligibility of Tenderer:-

- a) The tenderer should be a Goods Transporting Agency having registration under the competent authority of the concerned State where the Regd. Office of the tenderer is situated evidencing that they are authorized to transport goods across West Bengal Odisha border as well as inside the State of Odisha. The tenderer, if registered with the Indian Bank Association, may submit copy of the registration certificate with the General Bid.
- b) The tenderer must be registered with the Central Excise and Customs Department under the Service Tax Rules,1994. The copy of the registration certificate should be enclosed with the General Bid.
- c) The Goods Transporting Agency must have offices as well as godown at least at Kolkata and Jajpur Road (Odisha), besides having the same at other places of destination.
- 2) **Period of contract:** One year from to the date of issue of Work Order. However, the period of contract may be extended further on mutual consent basis.
- 3) **Termination of the contract:** IFCAL has the right to terminate the contract by giving 30 days notice without assigning any reason thereof. However, in the event of any breach of the terms of Work Order on part of the transporter, IFCAL shall be at liberty to terminate the contract giving 7(seven) days notice to the transporter and in that case, the security deposit of the transporter shall be forfeited.

4) Our weighbridge capacity & size:

(i) The capacity of the weighbridge installed in the factory premises of IFCAL is 30 MT and the platform size is 3mtr x 9mtr. Hence the transporter should

engage such trucks so that the gross weight does not exceed 30 MT and the wheel base shall be less than 9mtr.

- Environmental Criteria: The truck to be engaged by the transporter must posses a valid PUC (i.e Pollution Under Control) Certificate issued by the competent authority. In case of transportation of goods on "Full Truck Load" basis, copy of the PUC certificate should be furnished to us.
- 7) **Delivery Time of Consignment:** In case of transportation of goods on **FTL** (i.e Full Truck Load) basis, the transporter should place truck within three days of intimation (verbal/telephonic/written) from us/our supplier. The transporter should deliver the goods at our site within a period of 7 days of receiving the materials from the supplier.

In case of transportation of goods on **smalls booking basis**, the transporter should deliver the materials at their Jajpur Road godown within 10 (ten) days of receiving the material from the supplier. **In case**, the transporter fails to meet the above delivery schedule, IFCAL has the right to forfeit the Security Deposit and blacklist the supplier. Whenever urgent delivery of the material at our site is required, the transporter will be intimated the dispatch schedule and in such case, the transporter should ensure to expedite the transportation to meet our urgency.

- 8) The rate quoted should be inclusive of taxes, duties & all charges.
- 9) Loading at the loading point will be done by the consignor and unloading at destination will be done by the consignee.
- 10) Freight will be paid as per the actual weight in case of small consignment (except cotton waste, glass wool, electric bulb, cable, briquetting roller and wire rope etc).
- 11) In every consignment note, the gross weight of the material including packing should be mentioned by the transporter, failing which IFCAL reserves its option to arrive at the gross weight which would be final & binding on the transporter as well as IFCAL.

- 12) If the weight of a consignment is found to be less than 70 kg, a minimum chargeable weight of 70 kg would be considered.
- 13) Full truck load will mean a weight of 9 MT or any maximum permissible weight occupying the full space of the truck in case of light materials allowed under State Road Transport Rule.
- 14) In case of full truck load consignment, the transporter is liable to collect the materials from the consignor's godown/Works/site and arrange door delivery at consignee's site.
- 15) The transporter will transport the materials as per our requirement but certainly within 7(seven) days of our verbal/telephonic/written notice and in special case the transporter is required to deploy the truck promptly to meet our urgent requirement, failing which Idcol Ferro Chrome & Alloys Ltd (IFCAL) reserves the option to make alternative arrangement at the transporter's cost and risk.
- 16) Transit insurance, if any, shall be covered by Idcol Ferro Chrome & Alloys Ltd.
- 17) Any transit mishap should be informed by the transporter to IFCAL within 24 hours of the occurrence of the mishap in writing enabling IFCAL to take up the matter with their underwriter. In case the transporter fails to intimate IFCAL within this 24 hours any such transit mishap, it would be binding on the transporter to make good of such loss/damage as will be assessed by IFCAL.
- 18) The transporter shall be held responsible for the loss/damage/destruction/ deterioration and / or non-delivery of the goods arising out of their act and/or negligence. They will be liable to make good of such deficiency/loss.
- 19) In case of all incoming goods, the expression "consignee" will mean "Idcol Ferro Chrome & Alloys Ltd" and the consignor will be their supplier or contractor as the case may be.

The present price of HSD prevailing as on 23.01.2020 at Indian Oil Corporation Ltd's retail outlet situated at Jajpur Road is Rs.73.13 per ltr. For a variation to the extent of X% in the price of HSD as compared to the prevailing price of Rs.73.13 per ltr, the transportation charge would vary by 0.4X% per MT and shall be calculated per kg weight accordingly.

breakdown, accident, riot, flood or whatsoever which is beyond the control of

28) **Forfeiture of EMD:-** In case the tenderer opts to withdraw from the tendering

of IFCAL during validity period of the tender, the earnest money as deposited
